

**MEDIA SPECIFICATION:**

No religious, political or nude works in any medium please.

**2- Dimensional Art/Photography:**

All work must be framed and wired securely with the ends of the wires taped. All matting and frames must be clean and undamaged.

Note: Unframed oils and acrylics will be allowed only if finished on all sides. There is no size restriction. All work must have identification label on upper right corner facing the back.

**Sculpture:**

All sculpture must fit into the locked display case. Size restrictions are 22”H x 22”W x 22”D.

**Jewelry:**

Must be original, one-of-a-kind, hand constructed jewelry with or without stones or enamel, or other additions. Jewelry will be displayed in a locked case. ID label must be attached, as well as title card for exhibition.

Cut out labels and affix to back of work for ID purposes.

Leave a 1" space from the bottom. **PRICES WILL NOT GO ON THE TITLE CARD**, but will be listed in the final art brochure. Hand-written title cards will be not be accepted.
